7:10 PM Presentation: Aquatic Invasive Species, Oregon Marine Board, Glenn Dolphin, Aquatic Invasive Species (AIS) Coordinator

- Invasive species 101: Zebra/Quagga Mussels
 - o Threats to environment, economy, and recreation
 - Types of boat contamination (aquatic weeds, NZ mud snails, live bait, attached mussels, standing water in boat)
 - Mussel Biology
 - Size of thumbnail when adults
 - Females can release approximately 1 million eggs/year
 - Densities can reach into the hundreds of thousands per square meter
 - Can tolerate wide range of water temps, can exist frozen winters
 - Can survive out of water for extended periods of time 10-21 days
 - Can filter up to 1 liter of water per day per mussel (can starve out food

supply)

- Originally from Caspian and Black Seas, transported in 1980's
- o Mussel movement: attach to boats, anchors, line, and vegetation, waders, vegetation
- Economic Costs—need to maintain any equipment/structures in water to remove mussels
- o Recreational costs
- o Can intercept boats from other states
- Aquatic Weeds: Eurasian water milfoil/Hydrilla
- New Zealand Mud snails, several 1000 snails per square meter, disrupt food chains
- AIS Distribution Maps: Aquatic weeds, zebra/quagga mussels, NZ mud snails
- AIS prevention program
 - Formed in 2009 by OR Legislature. Modeled after Idaho, implemented by the OR State Marine Board and the OR Dept. of Fish and Wildlife
 - o GOAL: Protect environment
 - New permit fees \$5 annual fee (+\$2 service fee) per boat collected during boat registration
 - Mobile boat decontamination equipment
 - Inspection teams (Salem, Clackamas, La Grande, Central Point, Madras)
 - Signage (billboards)
 - Educational materials
 - Training
 - Law enforcement
 - One permit carried per boat over 10'
 - Permits have nothing really to do with cleanliness of boat, is a mechanism to raise funds for program
- West coast planning efforts
 - o 100th Meridian Initiative: Columbia River Basin Team structured under incident command system similar to forest fire plans
 - o Watercraft inspection trainings—regionally in western states
 - o Statewide trainings
- Oregon boat inspection trainings/boat decontaminations
- Clean launch law passed in 2009—illegal to launch boat with visible aquatic species
- Education and outreach activities
 - o Signs
 - o Report at 1-866-INVADER
 - o West coast campaign "Clean, Drain, Dry"
 - Don't allow contaminated water to re-enter waterways—go to gravel pad or commercial car wash
 - o 10'x5' border highway sign "Watercraft: State Law Requires Invasive Species Permit"
 - o Marine board outreach campaign 2008-2009 cartoon characters
 - o 2010 more outreach
- Question: cleaning felt boots/waders: scrub boots down before leaving site (dish scrubber).
 Best to leave them in the sun to dry.
- Will have stakeholders committee in July to take in feedback and improve program further.

8:15 PM Discussion: Fiscal Policy, Liz Redon

• Liz is serving on an OWEB committee for restructuring the council support grant application. There was discussion on a question regarding fiscal policies and councils that use a fiscal agent. OWEB staff said that even though there is a fiscal agreement outlining roles and responsibilities, OWEB wants councils to have a fiscal policy that says the watershed council has read the agents policy and approves. - Mad Creek/ODOT: Working on routing dollars efficiently. Is does not look like OWEB will be an option so trying to contract directly with Linn County.
- Weed inventory and control (Partnership w/Marion County): Received over 60 phone calls in response to mailing.
- Water Supply Planning (City of Salem): Will provide report "Options Paper" when it is available.
- Stout Creek: Will be working on in-stream projects with 2 landowners over summer 2010.
- **Upper Bennett Dam:** Bill is going to talk with groups about donations. Need to address fish mortality. Can look at diversion dam, boat slides, other sites on river trips.
