In the fall of 2020, the historic Labor Day wildfires devastated the western side of the Oregon Cascades. The North Santiam Watershed experienced devastating losses from the Beachie Creek and Lionhead Wildfires. These two wildfires intensely burned more than 50% of the watershed and displaced over 600 people from their homes in the Santiam Canyon.

The North Santiam Watershed Council promptly shifted its priorities to help the community members whose properties were affected by the wildfires with erosion control, plant and native seed distribution, and post-fire recovery on-site consultations.

2020–2021 Efforts and Accomplishments

- Post Wildfire Response and Recovery Programs:
 - ⇒ Marion Soil and Water Conservation District immediately provided funding of \$30k for postfire erosion control efforts in Marion County. The River Design Group assessed sites and plans to implement erosion control.
 - ⇒ City of Salem offered immediate funding of \$100k for post-wildfire restoration. The council and River Design Group were able to assist landowners with costs for erosion control supplies and planting material.
- The council contacted over 122 landowners, and more than 106 landowners received weed-free straw for erosion control in both Linn and Marion counties. 284 rounds of straw (156,200 lbs), and 1,690 bales (84,500 lbs) were distributed.
- * The council managed post-wildfire planting in February 2021 and native seed distribution for landowners impacted by the Beachie Creek and Lionshead Wildfires.
- The council was awarded a United Way Foundation Grant to support council capacity. With those funds, a full-time Watershed Restoration Specialist position was created, as well as a summer internship position.
- The council participated in the Oregon Department of Forestry Fuels Reduction project.
- Collaboration with Partners of the North Santiam continued remotely due to the Covid pandemic restrictions.
- * The council participated with the City of Salem and Marion County on hosting the *Eleventh* Annual North Santiam Basin Summit, via web platform, in spring 2021.
- * The council took on the Aquatic Invasive Survey & Treatment, phase 1, a project focused on Ludwigia and Yellow Flag Iris in ponds on private land and public park lands.
