The NSWC works with the property owner to ascertain which types of projects would be suitable for their property and what the benefits would be for them and the watershed public so that landowners understand their options, responsibilities and feasible outcomes of the projects. Projects include riparian and in-stream aquatic enhancements, weed management, plant establishment, culvert replacement, prairie and oak habitat restoration.
