#### **Board Minutes:**

# **Additional Discussions:**

Brent noted it was important that we reinitiate the Bureau of Reclamation outreach portion of the WaterSMART grant. Rebecca agreed. We need to get folks aware of the various water topics currently being discussed both locally and regionally.

Brad asked about natural regeneration of plant material in the burned areas. Rebecca noted how multiple groups are working on identifying the best available seed sources for native seedlings and how practitioners are discussing "assisted migration" given the shift in climate regimes we are seeing the watershed. Rebecca also noted the major concern related to invasive weeds getting established in the burned areas with all the newly exposed soils.

Brent noted the Santiam WCD has been getting a lot of calls related to the ice storm tree damage that is impacting Mill Creek and the canals. A lot of debris down causing issues. Currently, the cities and county

are making little progress and are waiting on possibly funding assistance through disaster declaration.	
Rebecca noted she would keep a look out for additional funding sources to assist with clean up.
