<u>6:10 pm</u> Minutes to Previous Meeting: Minutes of the previous meeting held on November 8, 2018 were brought to the floor. Brad motioned to approve the November 2018 minutes. John noted several corrections needed to be made. Rebecca took note of the corrections. Jan Irene made a second to approve the minutes with the corrections. No further discussion. All were in favor. 6:13 pm Funding Request: Rebecca asked the board for approval to attend the Institute for Generative Leadership's "Foundations of Generative Leadership Workshop." Presenter: Rebecca McCoun, Executive Director

Rebecca reminded the council of the NSWC Action Plan priorities and noted how the current projects fit into meeting those priorities. Rebecca provided an update on all open restoration grants, which include:

- Ankeny Wildlife Refuge OWEB Small Grant
- Westbrook Refuge OWEB Small Grant
- Bear Branch Creek Wet Prairie, Oak, Riparian and Instream Restoration OWEB Large Grant
- Marion County Weed District OSWB Grant NSWC is a partner on project on this project
- South Valentine Beitel Riparian Restoration & Plant Establishment (East & West)
- Bird Haven Floodplain Restoration in Plant Establishment phase
- Dieckman Slough Restoration in Plant Establishment phase
- Model Watershed Program projects in Plant Establishment phase
- Rebecca presented on two recent OWEB Large Grant submissions: Little North Fork Santiam
 Bank Restoration proposal and the Upper North Santiam Side Channel Reconnection proposal.

Rebecca then discussed collaborative projects:

- The South Santiam, North Santiam and Marion SWCD first Plan for Your Land workshop series will begin at the end of January.
- The ECONorthwest report on the value of water in the North Santiam will be released soon. A stakeholder meeting to present on the report is tentatively scheduled for February 19th at the Marion County Public Works Building in Salem.
- The Partners of the North Santiam have a working draft action plan they will be working off of over the next year.
- The Santiam Water Control District received another Bureau of Reclamation WaterSMART grant.
