
6:15 pm: Board approved Brandin moving forward with adopting the use of QB online.

6:16 PM Presentation - USACE Detroit Reservoir Update - Tim Ernster


Tim noted the USACE has conducted several outreach efforts recently. Providing the public with an update on what is going on and why? Currently they have dam operation restrictions due to seismic issues. They have not been able to operate at full pool. Part of the delay is related to not having the contractors available to do the seismic upgrades, so it is taking longer than expected.

The USACE has been doing outreach related to the draft EIS. The EIS comment period has closed. Tim noted the EIS will most likely get signed later next year (2024).




Tim noted they are operating the reservoirs at a lower level. They are storing less water for the fish. This allows the fish to not have to dive as deep and have easier access.




Tim went over the operations of the dams over the last year. He discussed some notable anomalies.

Restoration Project:

- 1. Post-Wildfire Riparian Restoration Project Spring treatments have finished up, except for 12acres of one landowners' property will get this done in the next week or two
 - a. June 8th and 16th were EDRR treatments (knapweed and false brome sites) and Postwildfire Riparian Restoration treatments (blackberry and scotchbroom).
- 2. MSWCD and Marion County collaboration event called "Weed Wrangle" outreach and education on management of common post-wildfire invasive weeds; Marie led a walk-and-talk with attendees. ~7 attended, one landowner came into the office later in the week to borrow a weed wrench for scotchbroom removal
 - a. Marion County and Marion SWCD have weed wrench to borrow for landowners
- 3. Bear Branch Restoration Project Mid-management practices have been discussed with Rosario; these activities need to occur by the end of Sept. USFW scheduled to mow EQIP site (~20acres) of Scotchbroom in the Fall. Site visit with Jarod Jebousek on Thursday of this week.
- 4. Letter of Agreements signed for bulk of sites for Aquatic Invasives Project; looking to treat John Neal Park, Lyons Ponds, Knife Pond and ODOT ponds within the next couple of weeks Mid-Santiam area of Ludwigia and YFI
- 5. Future Efforts EDRR/Marion County Parks Partnership
 - a. Marion County Environmental has set aside \$25,000 to assist with weed treatment and outreach to residents near their parks
 - b. We need IGA to receive funds

Collaborative Partnerships:

- 3. Multiple landowners reach out about log debris in rivers. What is our stance/protocol for such inquiries?
- 4. Emerald Ash Borer tab on website?

Other:

- 1. Review of documentation for 990 is underway. 2022 files have been picked up from Ascension.
 - a. MSA signed by Ascension

- b. Rebecca, Amy and I are meeting tomorrow in relation to NSWC operations and review of operating files from Ascension before sending off to CPA
- 2. Amy, Rebecca and I are meeting and working on internal operation protocols
 - a. Still working on acquiring access to bank account
 - b. Will have a Grants Status spreadsheet updated by next meeting
- 3. Funds request sent in for Post-wildfire Riparian Restoration Grant and EDRR Grant at end of May
- 4. Post-Wildfire Riparian Restoration Grant has been approved for carryforward to 2023-2025 biennium!
- 5. Brainstorming projects for grants in the fall and early winter timeframe. Ideas include:
 - a. OWEB Technical Assistance Grant Watershed Assessment, with post-wildfire impacts
 - b. OWEB TA for continuing Partners of North Santiam efforts
 - c. OWEB TA or Monitoring on Surveying/Modeling Effective Shade relates to ODEQ TMDIs
 - d. OWEB Monitoring Grant Post Wildfire Inquiry on Pesticide Use with increased weeds and weed management across stakeholder boundaries
 - e. Restoration Grant
 - f. Invasive Weeds EDRR surveys and treatments, possibly another Aquatic Invasives if possible?
- 6. Potential future meeting presentation: Dr. Emily Fairfax to do a presentation on beavers, and wildfire, drought and climate change research (https://emilyfairfaxscience.com) next board meeting or August?
- 7. NSWC Apparel Discussion

2020 Postfire Riparian Restoration Project and EDRR

- June 8th and 16th were EDRR Surveyed Site treatments (knapweed and false brome sites), and Post-wildfire Riparian Restoration treatments (blackberry and scotchbroom).
- Activities will continue for one more large site for Riparian Restoration Project, and EDRR sites that were supposed to be treated last summer
- Next Activity Fall Plant Establishment for Riparian Restoration Project; Continue to treat false brome, knapweed at John Neal Park and Taylor Park next week

Next steps: looking to treat John Neal Park, Lyons Ponds, Knife Pond, Chahalpam, and ODOT ponds within the next couple of weeks — Mid-Santiam area of Ludwigia and YFI. Still needing a few LOAs from surrounding private landowners but majority of the permissions have been acquired. Coordination with Fur Sure Outfitters to survey NS River stretch for Ludwigia







Abnormally high snow accumulation and late spring melt off benefitted refill conditions.






HISTORICAL RESERVOIR ELEVATIONS






OBSERVED SEASONAL WEATHER



Temperature	0.5°F cooler than normal











SNOWPACK TO-DATE

WACS Update:

Events, Outreach, etc:

- Weed Wrangle with Marion County- Led the invasive species walk and talk- had a great time using weed wrenches and engaging people about invasive species
 - O Note: this is one event in a series they are doing. On July 30th, they are hoping to have a bat box building event!
- Upcoming: Fire Aware, Fire Prepared meeting at the Lebanon Public Library, in conjunction with the Lebanon Fire Department- Planned for June 26th. Will cover fire resiliency information for all types of landowners.
- Tabling: Stayton Farmer's Market! Tomorrow!- Really looking forward to this one. Compiled several different resources for landowners who are looking to be firewise, as well as those that need post-fire resources. Also created a firewise game for the table, and should have some native plants to give away.
- Collaborated with a local private forest manager we have worked with previously to identify potential fuels reduction sites, as well as areas where fuels reduction could be continued.
 - Note: one thing I noticed with the areas where we have previously done fuels reduction is how many invasives have popped back up in the last couple of years in light of the disturbance.
- Burned Parks Tour- toured the burned parks in the North Santiam with Marion SWCD and Marion Environmental Services. This tour was very productive, and allowed our agencies to brainstorm ways to collaborate further in the area
 - Notably- a bioblitz for the Little North Fork via iNaturalist (a plant identifying app). This
 would allow us to see where invasive species are in the canyon, as well as reward
 participants for finding natives.
- Seed Collection with Marion SWCD, Rosario's team, and IAE-I am interested in the possibility of starting a seed library in the South Santiam. The thought here is that we could save seeds from areas that have not yet experienced fire. That way, if there is a fire, some native seeds from the area will be available.

Meetings and Planning

- Linn Community Wildfire Protection Plan (CWPP) Meetings- have been helping connect Linn County Planners to relevant community partners.
 - O Additionally, being a part of this process is really helpful for watershed councils as there are grants available based on what is written in these.
- Weed Wrangle Meetings- Attended a couple of these in preparation for the Weed Wrangle event- worked in conjunction with Marion Soil and Water Conservation District and Marion County Environmental Services.
- Meeting with the Fire Marshal of Lebanon- Had this meeting today (June 20) to help solidify our plans for the fire aware, fire prepared night next Monday evening at the Lebanon Library (June 26, 4:45-5:45pm)

- Long Term Recovery Group Meeting- This is the first month I have attended one, getting familiar with the way the group works and building a partnership.
- Partners of the North Santiam Meeting
- Collaboration meeting with Grand Ronde- looking at potential opportunities for fuels reduction. Will have a site visit this friday!

Other

- Working on a Story Map about the North and South Santiam Watershed councils and their relationship with fire.
- Created a "pocketbook of integrated pest management" for some common weeds seen in the Canyon. Handed this booklet out at the weed wrangle event, and will also hand it out at the farmers market.
- Creating a "baseline" fire presentation for future events, modified it to fit the fire aware, fire prepared goals.
- Created a Firewise diorama game for outreach events. Recorded how it was made and will be recording how successful it is with people.
- Continued to review most current science on wildfire. Learning a lot about potential grants.
