

6:25 – 6:41 Wildfire Adaptive Communities Specialist (WACS) Update – Marie Heuberger

Highlights: Fuel reduction projects, Xerces Society Pollinator Kit requested for 4 landowners, upcoming meeting in Sweet Home re: Emergency Response in Wildfires. Projects of weed treatments on North Fork Road re: readying for county parks to open. Research on Spanish written materials to support landowners. ORDA Bio-agent control kits received to stop scotch broom generation. Grant requests updates for Oregon Conservation and Recreation Fund. Upcoming presentation at Regis High School junior class.

Discussion: Readiness of parks on the North Fork for being open to the public.



6:41-7:09 Breitenbush Floodplain Restoration Project & Tour – USFS Agreement Update

- Thank you to partners for the excellent site tour and discussions Friday, April 19^{th.}
- Updates on meetings to learn more from partners about this type of project.
- Project Scope, Goals and Timeline (see ED staff report presentation) including implications of FIP application process and NOAA Fish Passage co-application with MVRC.

Discussion: How to communicate to the public at large of a huge restoration project being done so far from the public eye. Drone use and communication through social media weekly update is being used by McKenzie River Trust. Safety and security for people and equipment onsite. Knowledge of the funders and their way of managing with implementors. Access to the site for workers and equipment. Clarity of responsibilities and role of NSWC, communication, outreach, pass-through eases procurement for local contract selection in contrast to federal requirements, reporting, education. Key to this success will be the project manager which would be hired by the NSWC.

Summary and Board Vote: Suzette, President, proposed we vote on our decision to go forward with USFS.

Kathy Bridges made a motion that NSWC partner with the USFS to plan and implement the Breitenbush Floodplain Restoration Project and Brent Stevenson seconded the motion with the caveat that we will have the authority to review the contract before proceeding. All were in favor and agreed to move forward with the USFS.

7:09 pm: Financial Updates and 990 - Amy and Brandin

- Financial detailed reports from QuickBooks were presented.
- Finance Committee and staff still learning, and reviews happen on Tuesday and will review January and February balance sheets.
- Amy learning and paying attention to using QuickBooks for clarifying best practices and process.
- 990 reports are in from bookkeeping service and expect to meet the May 15th deadline.
- There will be a meeting next week to discuss 990 completions with the CPA, Vickie






North Fork - Breitenbush Floodplain Restoration

- Goals of the Project: Identified as an Essential Project for our Priority Watershed (2017)
 - Improve fish habitat for ESA-listed species (spring chinook salmon)
 - Improve fish habitat for all native species deep pools, log jams, side channels, healthy distribution of sediment size (cobble, gravel, silt)
 - Enhancement of Beaver habitat
 - Improve water quality stream temperature, sediment filtering
 - Create resilient habitat for the future (climate change, flood mitigation)
 - Raise water table in floodplain healthy distribution of riparian vegetation
- Met with Middle Fork Willamette Watershed Council and McKenzie Watershed Council
 - Offered to share resources and support
 - Has shared RFP for Deer Creek Stage 4 Restoration Project to use as a template
 - Big Proponent for these USFS Watershed Council partnership projects
- Project Tour on April 19
 - Board members and technical advisors
 - Great discussions and questions

General timeline (with 2025 implementation)



With considerations of a FIP Application (Focus-Investment Partnership), the application would be due in Fall (~Oct) of 2025. Assuming award of FIP is 6-8months from submission, projects could potentially be as early as Summer 2026 – 2032

We also have pending NOAA Fish Passage co-application with MVRC, which has budgeted Project Manager for Mill Creek dams environmental analysis, outreach and permitting. If awarded, this would take place from July 2024 – June 2026.






